Limit of Liability:

Insured

Public Liability: \$20,000,000 any one Occurrence, unlimited any one Policy Period

Products Liability: \$20,000,000 any one Occurrence, and in the aggregate any one Policy Period

Endorsements:

This policy excludes any cover for Recycling/Sorting/Waste Management activities.

Non Aggregation of Section Excesses:

It is hereby declared and agreed that in the event of a single occurrence that results in a claim under more than one Section of this Policy, We will only apply the largest of the individual Excesses under one Section that apply to the actual loss covered under each Section.

Other than as amended by this endorsement, all terms, conditions, definitions and exclusions applicable to this Policy shall continue to apply.

Extended Windscreen Protection (EWP)

Automatic Extension 22. Windscreen Replacement (of Automatic Extensions Applicable to SECTION ONE) is deleted and We will cover You if a Windscreen alone is damaged during the Policy Period:

- a. for insured items weighing in excess of 2 tonnes for the first loss in any one Policy Period to one Insured Item without the application of any Policy Excess up to a maximum of \$5,000.
- b. for Insured Items weighing 2 tonnes or under for the first loss in any one Policy Period to each individual Insured Item without the application of any Policy Excess.

Other than as amended by this Endorsement, all terms, conditions, definitions and exclusions applicable to the Policy shall continue to apply.

Environmental Impairment Endorsement (EIE)

Pollution, Harmful Materials

Irrespective of anything contained in the Policy to the contrary, cover provided under Section Three - Broadform Liability, the following additional Exclusions apply.

- a. Personal Injury or Property Damage directly or indirectly arising out of the discharge, dispersal, release or escape of Pollutants or Harmful Materials,
- b. The cost of removing, nullifying or cleaning up Pollutants or Harmful Materials,
- c. The cost of preventing the escape of Pollutants or Harmful Materials and
- d. The cost of reparation for environmental impairment.

Note: For the purpose of this endorsement, "Harmful Materials" means any material or substance harmful in any way to the health of people or the well-being of the environment.

Other than as amended by this Endorsement, all terms, conditions, definition and exclusions applicable to the Policy shall continue to apply.
